1. Register at the buyer's social (no obligation) which is held in the livestock show area beginning at 12:45 p.m.
2. Bidding on animals is based on price per pound.
3. Care of animals is the responsibility of exhibitor until Sunday evening.
4. Accounts to be settled with sales clerk at the end of sale.
5. Weight of animal will be final weight on fair entry date (August 9 or 10 depending on species).
6. Arrangements for slaughter and transportation to area processors must be made by the end of sale.
7. Additional information and marketing alternatives available at the sale.
