Questions from my Desk-Chair: Slowing Down on the Farm

Statistics show that the average age of land ownership on farms is 65. I have received many calls from farmers that want to slow down or move to retirement.

How can we make this decision? Where do we start? I would have to ask some tough questions. Does the farm carry any debt? If this is the case now we would have a conversation on how to manage the debt. Do we sell assets to reduce or remove the debt? Many times that would be the case. If debt is not a concern then a conversation with parties involved (the husband and wife) is required. I want both to be open and provide feedback on their concerns related to slowing down.

First, I would recommend making a list of their concerns with slowing down on the farm. Generally it is how to approach the risk involved or to reduce risk. Many have sold off the livestock already and some other assets. Many have been growing crops and decided it was too great a risk and age may cause them to reduce physical work. Therefore, they need to put together a list of concerns that the parties have related to the farm.

Second, now make a plan of action. This list will allow them to gather information before action is taken.

- Talk with your tax preparer. This is important to understand potential tax liability you may have if you sell or not sell assets.
- Review your will. If you need ask an attorney for some help.
- Talk with your family. If children don't have an interest in the farm, it is good to inform them of your plans for the future. If they are active on the farm, they should also know your desires.
- Have a date in your plan of action. Always have a date listed when an action should be performed by (example contact tax person by November 1st).

- Remember a plan of action is just dates to gather information.
- Develop and implement the plan.

The next question many will ask is I want to rent my cropland out, but I want to be fair and maybe capture added value with a variable rent when prices are good, is this a good idea? Yes, it can be, but how much risk do you want to carry into retirement? Variable rent is a good tool, but what does it cost to plant an acre of corn, soybeans, or alfalfa. Many don't know. I will always provide a snapshot of a crop budget and let the retiring farmers fill in blanks. Many times they are surprised the cost of planting a crop and the return is lower than they thought. In central Wisconsin many will just set a cropland rent per year. Much of our crop is grown to feed livestock and some crops may not have a true price determining outlet. Plus if forages are raised many don't have access to scales to determine yields.

So how do we arrive at a rental price?

National Agriculture Statistics Service (NASS) gather cropland rental rates and this is a good source to begin a conversation. Now there will be an on the street rental rate and it may or may not be accurate and what is in that cropland rental rate? Can the landowner and/or cropland renter think in a different manner? The landowner has an investment in land and land has a monetary value. If you had money to invest in a low risk investment, what would you like for a minimum return on your investment? Now look at the cropland as the landowner's investment and the cropland renter as the financial company paying on that investment.

If both parties agree that cropland is worth \$3,000.00 and the current rate of return is between 2% - 4% this would give a range of \$60.00 - \$120.00 per acre rent. Remember there may be other considerations in determining rental rates (lime, conservation practices, USDA payments, etc.)

Third, if you are renting land have a written contract. It may be for one year or five years. Spell out your desires in the contract related to rotation, soil testing, lime, fertilizer and the list continues. Hand shake agreements are OK, but only for one year at a time and sometimes parties involved forget what the handshake agreement contained. You can download examples of lease agreements from the county's webpage https://clark.extension.wisc.edu/cash-farm-leases/.

Congratulations on your ability to retire and reduce risk from the farm operation. It is important to manage your retirement much like your farm when you were actively farming.

CONSERVATION CORNER

Hi from the Clark County Land Conservation Department.

Nutrient Management Plans: I want to take some time to remind you that April 1st as in years past is the deadline for submitting to the department your updated nutrient management plan (NMP). Most plan writers working in Clark County are already aware of that deadline but it wouldn't hurt to remind them if you are having one updated your NMP. If you are doing your own NMP updated make sure your certification for self-planning is up to date just call Fred or Tiffanee in from our office and they will let you know if you need to attend the March trainings. There will be two opportunities in March to learn how to write your own NMP without a computer or get re-certified to write your own NMP in March. If you can not make either of these meetings then you are out of luck until next year.

Pre-Ordinance Manure Storage Inspections: Again we will be doing pre-ordinance manure pit inspections this years concentrating on the townships of Green Grove and Longwood. If you receive a letter from us don't get alarmed that we will be coming to make you close up your manure storage. The vast majority of pre-ordinance manure storages we inspect are fine to keep using as is but there have been a few that are not being used and it is obvious that they aren't going to be used again those are the ones that we would like to see closed up. There is cost sharing available from my department and NRCS to help cover the cost of closing up a manure storage. You need to get a permit from the Land Conservation Department before close up your manure storage, the permit and engineering plan to close up a manure storage is free.

Cover Crop Demo Plot Project: Again in 2024 we will be doing the cover crop demo plot trials on property owned by Clark Turner. In case you don't know the plots are located two miles south of the intersection of Hwy N and CTY O on the west side of O, look for the sign.

Water Quality Trading what is it? In case you are unaware there is another source of money out there to help cover the costs of installing a conservation best management practice (BMP) and it's called Water Quality Trading (WQT). A little back ground, several years ago the DNR started making municipalities reduce their phosphorous levels that they discharge into streams and rivers after going thru the treatment process. Now for most small municipalities building a new treatment facility is not financially possible so they came up with a second option paying someone usually upstream from the facility's discharge point to install a conservation best management practice, this could be taking a gully in a field and putting in a designed waterway, installing buffers a long a stream, installing a concrete cattle lot where any runoff goes thru a vegetative treatment area (VTA) before it can make into a surface water. There are numerous other practices that I won't get into here but I think you get the idea. If you are going to install a practice that helps protect our surface water why not get some help paying for it. Contact me if you would like more information WQT.

Engineering Projects: If you are considering any project that would require engineering services from us like, manure pit closures, well closures, waterway designing, etc... please contact Hunter Lemler in our office as this is a good time of the year to be working on designing before it warms up for good and things get busy.

No-till Drill: Our drill will once again be available to farmers. With the lack of snow this winter we could be looking at a dry spring for the start and soils don't have much for reserved soil moisture in them, tilling your soil will only make the problem much worse so why not plant no till.
